This guarantee is a continuing guarantee and shall remain in force until determined by us by notice in writing providing that:-

- (1) our liability hereunder shall be limited to a payment or payments not exceeding *£..... in aggregate and any demand must be received at our office at the address shown in the box below not later than 33 months from the date of Notice of Determination.
- (2) this guarantee shall not apply to any individual Carnet issued by you after the expiration of 33 months from the date of issue of such Carnet.
- (3) this guarantee shall be delivered up by you to us when no longer required.
